Chapel Named in Remembrance of Former St. Ann's Elder and Family




"We went to mass together for several years while he lived on the 7th floor of St. Ann's Home," says Walter. "Sometimes afterward I'd take him out for supper. He loved hot dogs so we went to Schaller's a lot. He really enjoyed that."

Anthony Fedele was the father of Walter's first wife, Carmina. When she passed away, Walter took on the role of primary caregiver, remaining close to his father-in-law during his seven years at St. Ann's. When Anthony later passed, the memories of their time spent in the Chapel remained with Walter. "I've always had a soft spot for the Chapel," he says, recalling the Christmas parties his family would attend with Anthony after Christmas Eve masses.

Now 90, Walter remains active with O'Connell Electric, the business he bought in 1968 and for which he serves as chairman. It was through a business connection that he met his second wife Barbara, who worked as an information technology auditor. The couple have been longtime supporters of St. Ann's Community and their faith remains strong.

They belong to St. John the Evangelist in Rochester and also attend St. Mary's in Canandaigua. Their faith came into play when the couple made a generous gift to

Creativity Brings 70th Anniversary Couple Together Despite COVID

What could have been a miserable way to spend an anniversary turned out to be twice the fun thanks to the staff at St. Ann's Community at Cherry Ridge.

When Resident Services Manager Patty Finnigan learned that Bob and Betty Heindl (95 and 94 years old) would soon be marking their 70th wedding anniversary, she knew they had to do something about it.

"70 is huge!" says Patty. "Statistically, how many people reach that? I knew we had to do something special for them."

But COVID-19 presented a dilemma. Bob lives at St. Ann's Care Center, the skilled nursing center at Cherry Ridge, while Betty lives in the independent living apartments. With COVID-19 precautions in place, they could not get together or have inperson family visits. Patty joined forces with Regina Dennis, Life Enrichment Coordinator at St. Ann's Care Center, and with help from their colleagues they devised a creative workaround: a special celebration at Bob's window. It was double the fun.

"We had two cakes, one in Bob's room and one outside, plus champagne, flowers, a banner, everything to make it a celebration," Patty says. They were given special permission to have four guests at the window instead of two—the couple's four children, who joined the Cherry Ridge staff in celebrating the happy couple. As for Bob and Betty, they talked and toasted by phone and blew kisses through the window.

"They were so happy," says Patty.

The event shows the creative spirit of the Cherry Ridge staff when it comes to their elders. From independent to assisted living,



memory care to skilled nursing, staff from across the campus have risen to the challenge of bringing joy to elders during the trying times brought on by the pandemic.

"I'm so pleased we were able to pull it off to honor them even though they couldn't be in the same room together," says Patty. "They deserved something special, and we made it happen for them."

Living space that's as comfortable as the homes our elders are used to... the scent of home-cooked meals filling the air...more social and therapeutic activities offered right on elders' floors.

The historic renovations taking place at St. Ann's Home are bringing those features and more to life, ushering in a new era of senior care and giving our elders and their families the vibrant, healthful, modern living space they expect in 2020 and beyond.

It has to do with honoring a debt we believe we owe them. We recognize that the generation we are caring for built the world we live in today. Whether serving in the military, working in factories, raising families, staffing our schools and hospitals, or doing countless other jobs in their younger years, today's seniors are responsible for the blessings we enjoy every day.

That's why we are proud to call the capital campaign behind our renovation project *For All They've Given*.

"We owe our seniors a debt of gratitude for the hard work and sacrifices they made so that we can live the lives we do today," says Campaign Chair Jim Leo. "This landmark renovation project is a step toward repaying that debt by creating

the environment that our seniors want and deserve."

The "new-look" of St. Ann's Home will bring a fresh sense of color, light, and space to the seniors who call it home. Each floor is being completely redesigned and renovated, with new layouts, options, and amenities to enhance elders' quality of life and build meaningful bonds with staff.

In place of the long, dormitory-style hallways that have existed since 1963, we are adopting a warmer "household" model that allows for a more intimate delivery of care. Each floor will have two households of 15 seniors (rather than 46 seniors per floor in the current model). The households will share a full kitchen where hot, delicious meals will be prepared daily.

"Think of how the aromas will trigger the appetites of our elders," says Michael E. McRae, President and CEO of St. Ann's Community. "It's part of that warm feeling that makes a house a home, and we're bringing that to them. It's a game changer."

Residents will enjoy larger resident rooms, each with its own heating and air conditioning controls to accommodate individual preferences. Each household will have its own care team, creating

> stronger connections among staff and elders. And larger common areas mean more social and therapeutic options for elders right on their floors.

"We are bringing our 57-year-old building up to today's standards, with the flexibility to provide even more of what our seniors and their families are looking for," says Michael

McRae. "It's their home, and we want it to feel that way."

"You're investing in the most important piece of all, our elders." That, according to Ron Salluzzo, is why he and his wife Sharon have long supported St. Ann's capital projects.

Today, the Salluzzos are proud to support the campaign *For All They've Given*. What they find most gratifying is the impact their philanthropic gifts have on elders' quality of life. It's also why they encourage others to consider supporting the renovation.

"We're proud that we're helping move things forward, knowing St. Ann's is using the finances at their disposal the right way—to benefit the elders," says Ron. "How can you not be impressed by that?"

In addition to Ron's many years of serving on St. Ann's Board of Directors (which he currently chairs) and Foundation Board, the couple also have a personal connection to St. Ann's: Ron's aunt lives at Chapel Oaks and his mother at St. Ann's Care Center.

"When my aunt was living on her own, I saw her independence turn to isolation," he says. "Since coming to Chapel Oaks she's made new friends, has a robust social life, and is happier and healthier than she's been for years."

Sharon says that personal experience brings to life the decisions Ron is part of as a Board member.

"The personal side shows how things at the Board level are put into action," she says. "You see that

your loved ones are thriving, and you want that for other families as well. It's invigorating to see the care being exhibited at all levels, from the top right down to the people working with our loved ones every day."

When most of us see a building, we see steel, concrete, and glass. Mauricio Riveros sees opportunities.

"Buildings are complex things," says Mauricio, president of LECESSE Construction. "They represent an opportunity to create an exciting environment for the people who live and work within them."

That approach is at the heart of the innovative renovation work being done at St. Ann's Home under LECESSE Construction as general contractor.

"People are living into their 90s and 100s and they're still having fun!" says Mauricio. "St. Ann's recognizes this in its vision of 'caring for the most important people on earth'. And it's reflected in this renovation project, which is creating an environment where elders can be more connected socially and continue to enjoy their lives."

Mauricio and his wife Bess have personally made a generous philanthropic gift to support the renovation. They understand the direct impact it has on the lives of St. Ann's elders.

"We're proud to help fulfill St. Ann's vision of honoring and recognizing the value of our elders, who've done so much for us and our community," he says. "We know they will enjoy the new look, feel, and modern design that this landmark project is achieving."

The Browncroft and Upper Falls Households are now complete on the 8th floor and elders are marveling at their new surroundings. With work on the 7th floor expected to be completed this fall, Mauricio looks forward to the project progressing.

"We've created this beautiful environment (on the 8th floor) and soon it will encompass the entire building," he says. "We're elevating the space to a level today's seniors deserve."

Employee Scholarship Carries on Family Tradition of Education

When Tony Malone's grandmother came to America from Italy in 1910, she vowed that her children would know the value of a good education.

"She was a strong advocate for education for her children," says Tony, whose mother Anne was one of seven. "It was a priority for that generation, including my mother."

More than a century later, that priority lives on.

In 2020, Tony established the Cascio-Malone Family Scholarship Fund to help employees of St. Ann's Community further their education. It's named for his mother, Anne Cascio-Malone, who taught in the Elmira School District for 42 years. Anne lived at St. Ann's for 10 years before passing away just one day shy of her 103rd birthday.

"I was always impressed with the care the staff provided not just to my mother but to all the elders," says Tony. "They are genuinely caring and treat their responsibility as more than just a caregiver. There are some wonderful personal relationships that develop between staff and elders."

When his father died, Tony, an only child, took on the role of caregiver



for his mother. When Anne began showing signs of dementia in her 90s, they decided on St. Ann's for her continued care.

A retired civil engineer, Tony was a member of St. Ann's Board of Directors in the 1980s and '90s including a period as Board chair. Through that experience he became aware of the hurdles many St. Ann's employees face in their quest to advance their education. His mother's lifelong commitment to teaching also continued to resonate.

"When I learned there was a strong need for scholarships, I decided

to focus in that direction," says Tony. The Cascio-Malone Family Scholarship now helps St. Ann's employees pursue their educational goals, easing the financial burden that might otherwise prevent them from doing so.

How does Tony think his mother would feel about the scholarship created in her honor?

"I think she'd be excited that her legacy in the education field would be carried on for new generations," he said. "She'd be very supportive."

Cascio-Malone Family Scholarship Employee Recipient: Peter Thomas

When the COVID-19 outbreak led to a national shortage of personal protective equipment, 3D printing came to the rescue.

The technology makes it possible to create three-dimensional solid objects—for example, surgical masks or face shields—from a digital file by successively adding layers of material on top of one another. Like other industries, the healthcare field is finding it a fast and efficient way to make the medical supplies needed by patients and staff alike.

Peter Thomas would like to bring that technology to St. Ann's Community.

"I want to look at ways that technology can help St. Ann's provide high-quality care," says Peter, who has worked at St. Ann's for eight years. "In particular, I'm curious about how 3D printing may be able to create a 'Just in Time' type of solution to medical supplies, so we can have them right when they're needed."

That curiosity led him to enroll in the Integrative Design Masters Program at RIT. And the first Cascio-Malone Family Scholarship is helping him do that.

"School is difficult enough without having to worry about how to pay for it. The scholarship helps alleviate some of that stress," says Peter, a former St. Ann's Care Coordinator and now an Associate Educator in the Department of Education.

Peter says the supportive culture at St. Ann's makes it possible for him to pursue his Masters Degree part-time while continuing to work full-time.



"I'll be able to balance work and school because my

director has been flexible about my schedule and creative with how I can continue to support the department but also get my school work done," he says. "I also have an amazing family. My wife and son are both supportive of me going back to school."

With the scholarship, Peter was able to buy the computer he needed for his program of study. But it also means something much deeper.

"It means that St. Ann's and the donors are willing to invest in my education, and I'm so appreciative of that," he says. "Many St. Ann's employees benefit from the scholarship program. It helps build a new future for all of us."

Chapel Oaks

In-House Pizzeria Brings Pizza and More Right to Residents' Doors

Who ever heard of an Italian pizzeria serving German and Korean food?

The residents of Chapel Oaks have, and they love it!

Cappella's Pizzeria (the name means *chapel* in Italian) opened in June at Chapel Oaks. Its opening was one of those bright moments that emerged in the midst of the dark days of the initial COVID-19 lockdown. Knowing that residents could no longer come out for dinner, Executive Chef Todd Klugh decided to bring dinner to them.

"We started with a grocery delivery service for our residents, which was a huge hit, and it grew from there," he says.

Todd and his staff began delivering meals to residents' apartments, just one of the ways Chapel Oaks found new and safe ways to meet its residents' needs and relieve their isolation. Then an idea occurred to him.

"I know our residents like their pizza, so I thought we'd have some fun."

Chapel Oaks residents can now get pizza—and much more—delivered to their door during Cappella's Sunday hours, 2:00-6:00 pm.

The "much more" includes some of Chef Todd's personal specialties like grilled leberkase, locally made German-style bologna served on rye bread with dijon mustard and sweet pickles. He learned that one while working in Germany years ago. "We've got a lot of German residents, so that gives me an opportunity to practice my German," he says.

The menu also includes Korean BBQ pork tacos and drunken mussels among other entrees, plus salads, sandwiches, burgers, wings, and of course pizza. Residents also enjoy the dessert menu which includes banana splits, milkshakes, and root beer floats.

"One couple calls every week and orders shrimp cocktail, a salad, and milkshakes," says Todd.

While offering to-your-door delivery meant a change in the way the dining staff operates, it has also provided new opportunities to connect with residents since they



can no longer interact in the dining room.

"We deliver up to 80 meals a day right to their door; some residents call every day. So we get to know them more closely and have the chance to have non-food conversations," says Todd. "The overwhelming response is, 'Thank you, it's amazing.' And that makes you want to do even more to make their lives more enjoyable."
